New 1 & 2 Family Dwelling Unit: (Per OAR 918-050-0100: New construction includes 1 bathroom/1 kitchen plus the first 100 feet each of water and sewer lines, hose bibs, ice maker, underfloor low-point drains and rain-drain packages including piping, gutters, downspouts and perimeter system) (Does not include any storm water retention/detention facility, irrigation system, fire suppression system, or additional piping beyond the first 100 feet as noted above)

Additions, alterations or repairs: Fees shall be calculated based on the number of fixtures, appurtenances, and piping with a set minimum fee. Re-pipe fee is per the schedule below.

Minimum Permit Fee	\$49.50
