ORDINANCE NO. 287

AN ORDINANCE ADDING NEW SECTION 10.400, AMENDING SECTION 10.430, AND RENUMBERING OLD SECTIONS 10.400-10.440 OF THE WILSONVILLE CODE AND DECLARING AN EMERGENCY.

WHEREAS, the Wilsonville Parks & Recreation Commission has expressed concern about the danger presented to persons and property by persons diving from public pilings at the boat dock and at the swimming dock in Wilsonville Memorial Park and Boone's Ferry Park; and

WHEREAS, it would be in the interest of public health, safety and welfare to prohibit diving from public pilings;

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS

<u>Section 1</u>. A new Section 10.400 is hereby added to the Wilsonville Code as follows:

"10.400. Diving From Public Pilings. (1) No person shall dive or jump from, or climb or sit on, public pilings at the boat dock or at the swimming dock in Wilsonville Memorial Park or Boone's Ferry Park.

(2) Violation of this section is punishable as a violation pursuant to Section 1.012."

Section 2. Section 10.430 shall be amended to add the words "Except as otherwise specified," at the beginning of the section.

<u>Section 3</u>. Old Sections 10.400 to 10.440 shall be renumbered as 10.500 to 10.540.

Section 4. In the interest of the general health and welfare of the Citizens of the City of Wilsonville that this Ordinance be put into effect immediately, an emergency is hereby declared.
