## ORDINANCE NO. 300

AN ORDINANCE OF THE CITY OF WILSONVILLE REGULATING THE ERECTION, CONSTRUCTION, ENLARGEMENT, ALTERATION, REPAIR, MOVING, REMOVAL, DEMOLITION, CONVERSION, OCCUPANCY, EQUIPMENT, USE, HEIGHT, AREA AND MAINTENANCE OF ALL BUILDINGS AND/OR STRUCTURES IN THE CITY OF WILSONVILLE; PROVIDING FOR THE ISSUANCE OF PERMITS AND COLLECTION OF FEES THEREFORE; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; AMENDING SECTION 9.000 OF CHAPTER 9 OF THE WILSONVILLE CODE OF THE CITY OF WILSONVILLE.

THE CITY COUNCIL OF THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. That certain documents, one (1) copy of which is on file in the office of the City Recorder and the City of Wilsonville, being marked and designated as "UNIFORM BUILDING CODE" and "UNIFORM BUILDING CODE APPENDIX", 1985 edition and the "UNIFORM BUILDING CODE STANDARDS", 1985 edition, published by the International Conference of Building Officials, and as so amended and supplemented by the 1986 edition of the State of Oregon Structural Specialty Code and Fire and Life Safety Code, be one and the same is hereby adopted as the Code of the City of Wilsonville for regulating the erection, construction, occupancy, equipment, use, height, area and maintenance of all buildings

and/or structures in the City of Wilsonville providing for issuance of permits and collection of fees thereof; providing penalties for violation of such code; and each and all of the regulations, provisions, penalties, conditions and terms of such "UNIFORM BUILDING CODE", 1985 edition, and the "UNIFORM BUILDING CODE STANDARDS", 1985 edition, published by the International Conference of Building Officials, and as so amended and supplemented by the 1986 edition of the State of Oregon Structural Specialty Code and Fire and Life Safety Code, on file in the office of the City Recorder and the City of Wilsonville are hereby referred to, adopted and made a part hereof as if fully set out in this ordinance.

Section 2. That Section 9.000, Chapter 9 of the Wilsonville Code is hereby amended.

Section 3. That if any section, sub-section, sentence clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council declares that it would have passed this ordinance, and each section, sub-section, clause or phrase thereof, irrespective of the fact that any one or more sections, sub-sections, sentences, clauses and phrases be declared unconstitutional.
