ORDINANCE NO. 305

AN ORDINANCE AMENDING ORDINANCE NO. 302 WHICH ADOPTED FINDINGS AND AMENDED THE COMPREHENSIVE PLAN TO CORRECT THE AFFECTED TAX LOTS IN ORDINANCE NO. 302; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

<u>Section 1.</u> The Planning Director is authorized and directed to make amendments to the Comprehensive Plan Map to reflect the following corrections:

- (a) The section number for Tax Lots 300-5701 shall be corrected from Section 23BC to Section 23AC, Clackamas County, Oregon.
- (b) Tax Lots 900-1700, T3S-RIW, Section 23BD, Clackamas County, Oregon, shall be included as affected parcels.

Section 2. It is hereby determined by the Wilsonville City Council that expediting land use actions is in the interests of public health, safety and general welfare. Therefore, an emergency exists. This ordinance shall take effect immediately upon final reading and passage by the Wilsonville City Council.
