## **RESOLUTION NO. 1806**

A RESOLUTION ACKNOWLEDGING THE CERTIFICATION OF THE NOVEMBER 5, 2002 GENERAL ELECTION RESULTS BY THE CITY RECORDER THE CITY'S ELECTION OFFICIAL.

  - a. That Alan Kirk has been elected to the position of City Councilor for a four-year term beginning January 1, 2003.
  - b. That Sandra Scott-Tabb has been elected to the position of City Councilor for a four-year term beginning January 1, 2003.
  - c. That Ballot Measure 3-78 has received the majority affirmative votes.
  - 2. This resolution becomes effective upon adoption.


