

**RESOLUTION NO. 1819**

**A RESOLUTION OF THE CITY OF WILSONVILLE AMENDING RESOLUTION NO. 1732 TO ADJUST THE STORM WATER AND STORM WATER QUALITY MANAGEMENT FEES FOR THE COFFEE CREEK CORRECTIONAL FACILITY.**

WHEREAS, Resolution No. 1732 establishes just and equitable storm water systems development charges and a surcharge fee for storm water and storm water quality management; and

WHEREAS, the surcharge fee for storm water and storm water quality management fee includes in part, the following:

Anticipated debt service payments for storm water capital improvements.

Payment of part of the capital improvements directly from the storm water utility fee.

Collection for the City maintenance of the storm water system to provide the capacity for flows in excess of the 25-year storm; and

WHEREAS, the Department of Corrections has paid for all of the capital improvements necessary to provide for the storm water runoff from the Coffee Creek Correctional Facility and would receive no benefit from paying for additional debt service for capital improvements or for that portion of the surcharge that would go to storm water systems improvements; and

WHEREAS, the Department of Corrections has designed the storm water detention system at the Coffee Creek Correctional Facility to detain the 100-year storm, thereby reducing runoff; and

WHEREAS, the Department of Corrections has requested an adjustment in the storm water utility fee to only pay for that part of the fee for which they receive benefits; and

WHEREAS, staff has reviewed the surcharge for storm water utility fees and determined that the fees for the Coffee Creek Correctional Creek Facility could be reduced by 39.3% to allow for equitable treatment for the Department of Corrections.

NOW, THEREFORE THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. The following subparagraph shall be added to Article 3, Storm Water Surcharge Collection, Section 1 of Resolution No. 1732.


The surcharge for the Coffee Creek Correctional Facility per equivalent residential unit shall be established at 60.7% of the surcharge for a single-family unit effective March 1st, 2003.

2. This resolution is effective upon adoption.
