RESOLUTION NO. 1909

A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE NOVEMBER 2, 2004 GENERAL ELECTION.

WHEREAS, at the General Election held November 2, 2004, the electorate of the City of Wilsonville cast ballots for Mayor and two City Councilor positions; and

WHEREAS, Ballot Measure 3-136 which amended the City Charter to provide the opportunity to vote on new City Hall Building at a statutory election date also was voted upon during the November 2, 2004 General Election; and

WHEREAS, the terms of Mayor and of the City Council positions are four-year terms, and

WHEREAS, the General Election of the registered voters of Clackamas County was conducted by mail; and

WHEREAS, the County Clerk of Clackamas County, who by statute, is in charge of conducting all elections, has filed an abstract of the tally of votes cast at the election, which tally for Clackamas County was duly received by the City Recorder on November 22, 2004; and from Washington County was duly received by the City Recorder on November 24, 2004, copies of which are attached hereto and incorporated by reference.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. That the City Council of the City of Wilsonville does hereby adopt the votes of the November2, 2004, General Election as follows:

Ballot Measure 3-136 which authorizes the City Charter to be amended as follows, "Section 44: "A regularly scheduled city election shall be defined as the general election held on the first Tuesday after the First Monday of November in even numbered years or such special election called by the city council for a statutorily scheduled county election date in March, May, September or November." has passed having received the affirmative majority of the legal voters cast on Ballot Measure 3-136 and entitled to be counted thereon.

4. The City Recorder shall file the Certificates of Election in accordance with the above.

d. That **Ballot Measure 3-136** authorizing an amendment to the Wilsonville City Charter has passed having received the affirmative majority of the legal votes cast on Ballot Measure 3-136 and entitled to be counted thereon.
