RESOLUTION NO. 1976

A RESOLUTION OF THE CITY OF WILSONVILLE EXCHANGING AND ADOPTING EASEMENTS, ARBOR VILLEBOIS LLC, GRANTOR

WHEREAS, the City of Wilsonville approved the subdivision plat known as "Arbor Villebois", Case File 04AR056, which required that a public utility easement be conveyed to the City; and

WHEREAS, the developer provided an easement on the property known as Lot 40 an easement recorded as Plat #4002 in Book 131, Page 14, Clackamas County, Oregon. However, the location of this easement was larger and did not track the requirements of the easement described above; was in excess of the needs and requirements of the Public Works Department and, therefore, a portion of said easement is no longer needed by the City of Wilsonville; and

WHEREAS, the City Council finds that it is in the public interest to exchange a quitclaim deed for a public utility easement of the appropriate size pursuant to ORS 271.310.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1. Based on the above recitals and findings, the City of Wilsonville adopts, approves and, authorizes the following conveyances to achieve an exchange of easements:
- (a) The City's release, by a Reconveyance and Quitclaim, of all its interest in the Public Utility Easement described in Exhibit 1, attached hereto and incorporated herein, in exchange for
- (b) Arbor Villebois LLC's conveyance to the City of the Public Utility Easement described in Exhibit 2, attached hereto and incorporated herein.
 - 2. The City Manager is authorized to sign these instruments on behalf of the City.
 - 3. This resolution is effective upon adoption.




