

RESOLUTION NO. 1990

A RESOLUTION ACCEPTING BIDS AND AWARDING THE CONTRACT TO THE LOW BIDDER, PGE FOR REPLACEMENT OF STREET LIGHTS AND STREET LIGHT POLES.

WHEREAS, the FY 2005/06 Capital Projects list for streetscape/bicycle projects includes Project Number 4697 for the Streetlight Replacement Program in the amount of \$171,000; and

WHEREAS, Public Works has surveyed the City streetlights and has selected approximately 100 streetlights and poles in Courthouse, Montebello, Serene Acres and Fox Chase that need the repair; and

WHEREAS, Staff solicited three bids and received the following bids:

PGE:	\$128,275
Boones Ferry Electric:	\$260,050
Wilsonville Electric:	\$170,160



WHEREAS, all three bidders are competent firms that are capable of doing the work.

NOW THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:


1. The City Council acting in its capacity as the Local Contract Review Board approves staff recommendation and the award of the 2006 Light Pole Repair and Replacement Contract to PGE with payment from streetlight funds Project Number 4697 not to exceed \$171,000.
2. The City Manager or her designee is authorized to enter into the contract on behalf of the City of Wilsonville.
3. This resolution is effective upon adoption.

RECOMMENDATION:

That Council acting as the Contract Review Board approves the accepted bids and awards the contract to the low bidder, PGE for replacement of streetlights and streetlight poles with payment from Capital Project No. 4697 and not exceed \$171,000.

SUMMARY:

The Capital Improvements Plan for FY 2005/06 includes a streetlight and pole replacement project which is numbered 4697 at \$171,000.

Public Works has solicited bids and received the following bids:

PGE:	\$128,275
Boones Ferry Electric:	\$260,050
Wilsonville Electric:	\$170,160

All three firms are qualified to accomplish the work and PGE is the low bidder at \$128,275.

Staff recommends that the contract be awarded to PGE so that the work can be accomplished during the spring and summer construction season.
