A RESOLUTION OF THE CITY OF WILSONVILLE ACCEPTING A STREET DEDICATION FOR A PORTION OF CANYON CREEK ROAD ASSOCIATED WITH ALL OF PARCEL 2 OF CLACKAMAS COUNTY PARTITION PLAT 1997-45.

WHEREAS, the City of Wilsonville is the owner of real property containing the completed improvements to Canyon Creek Road, also known as Tax lot 2502 in Map Section 13B of Township 3 South, Range 1 West, Willamette Meridian; and

WHEREAS, said property was partitioned and identified as Parcel 2 in Partition Plat 1997-45, in Clackamas County records for roadway purposes; and

WHEREAS, portions of Canyon Creek Road have been constructed over said property; and

WHEREAS, the City Engineer recommends the transfer of the real property containing Canyon Creek Road to public right of way; and

WHEREAS, the Public Works Department will continue to operate and maintain the existing City street and infrastructure.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1. The street dedication, legal description, and exhibit map, copies of which are marked "Exhibit A", "Exhibit B", and "Exhibit C" respectively, attached hereto and incorporated herein are herby approved for execution by the City of Wilsonville.
- 2. This resolution is effective upon adoption.

SUMMARY

The attached Resolution No. 2145 authorizes transfer of Parcel 2 of Partition Plat 1997-45, also known as 31W13B02502 in Clackamas County records, from the City of Wilsonville as the private property owner to the City of Wilsonville as public right of way for roadway purposes through a Street Dedication. The dedication will transfer property and continue the operation and maintenance of the existing Public Street and infrastructure by the Public Works Department.

RECOMMENDATION

Staff respectfully recommends that the City Council approve the dedication of Canyon Creek Road.

DISCUSSION

The Resolution is for the transfer of Tax lot 2502, in its entirety, from a City of Wilsonville parcel to public right-of-way. This portion of Canyon Creek Road is currently operated and maintained by the Public Works Department. The dedication of this public right-of-way will maintain consistency with other property that has a public roadway constructed upon it. This dedication is a continuation of project #4145 for the dedication of public right-of-way for all streets operated and maintained by the City of Wilsonville.

A tract of land situated in the NW 1/4 Section 13, Township 3 South, Range 1 West, Willamette Meridian, Clackamas County, being Parcel 2 of Partition Plat 1997-45, Clackamas County plat records and being more particularly described as follows:

Beginning at the Southwest corner of said Parcel 2, from which the Northwest corner of Parcel 1 of said Partition Plat 1997-45 bears North 01°47'04" East, 329.91 feet;

Thence, along the West line of said Parcel 2, North 01°47'04" East, 46.28 feet to the Southwest corner of said Parcel 1;




