## **RESOLUTION NO. 2252**

A RESOLUTION OF THE CITY OF WILSONVILLE AMENDING THE ACCESS CONTROL PLAN FOR THE WILSONVILLE ROAD PHASE 4 PROJECT AS REGARDS THE PROPERTY LOCATED AT 10925 SW WILSONVILLE ROAD

WHEREAS, on January 18, 2001, the City Council of the City of Wilsonville adopted Resolution No. 1687, approving and adopting an Access Control Plan for the Wilsonville Road Phase 4 Project; and

WHEREAS, on April 3, 2001, the City of Wilsonville (City) and Russell L. Guiss (Property Owner) entered into an Access Agreement limiting access to the property located at 10925 SW Wilsonville Road to a single right turn in/out only in accordance with Resolution No. 1687; and

WHEREAS, the City of Wilsonville and the current property owner, the Russell L. Guiss Trust, wish to amend the Access Control Plan to allow retention of the access limitation through subsequent changes in property ownership until such time as the property redevelops in accordance with the City's land use and comprehensive codes or there is a demonstrated safety-related issue with maintaining the existing access necessitating closure of the direct access to Wilsonville Road as determined by the City Engineer.

# NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1. The above recitals are incorporated by reference herein.
- 2. Amendment #1 to the Access Agreement Between the City of Wilsonville and Russell L. Guiss Trust, a copy of which is attached as Exhibit A, is hereby approved and the City Manager is authorized to execute Amendment #1.
- 3. This resolution is effective upon adoption.

#### SUMMARY

In accordance with Ordinance #551, the City has jurisdiction and regulatory control over its rights-of-way under its City Charter and state law. Accordingly, the City has the ability to establish an access control plan for Wilsonville Road. As part of the design process for the reconstruction efforts, it was determined that some of the existing vehicular accesses along the roadway would require closure, combination and relocation to meet the provisions of mandated level of service 'D' provisions. By previous action the City Council has adopted and Access Control Plan for Wilsonville Road Phases 2B, 3A, 3B and 4 which reconstructed and widened Wilsonville Road from the Burlington Northern Railroad Tracks west to the City Limits.

Accordingly, the City entered into an agreement with Russell and Norma Guiss modifying the access from their property to Wilsonville Road. The provisions of the agreement indicate the agreement is to remain in effect as long as they 'own' the property. The owners now wish to sell the property and have asked the City to modify the agreement to reflect this.

# RECOMMENDATION

Staff respectfully recommends that the City Council approve the attached modification to the Access Control Plan for Wilsonville Road as previously adopted.

### **DISCUSSION**

With the completion of the access modifications outlined under the provisions of the previous agreement; there have not be any significant issues associated with the access (accidents etc.) and further, Staff does not anticipate any issues regarding same with adoption of the agreement modification. It is anticipated that redevelopment of the property would necessitate additional studies to see if the access does indeed require close or modification.
