

**RESOLUTION NO. 2260**

**A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE NOVEMBER 2, 2010 GENERAL ELECTION.**

WHEREAS, at the General Election held November 2, 2010, the electorate of the City of Wilsonville cast ballots for two City Councilor positions; and

WHEREAS, the terms of the City Council positions are four-year terms, and

WHEREAS, the General Election of the registered voters of Clackamas County was conducted by mail; and

WHEREAS, the County Clerk of Clackamas County, who by statute, is in charge of conducting all elections, has filed an abstract of the tally of votes cast at the election, which tally for Clackamas County was duly received by the City Recorder on November 22, 2010; and from Washington County was duly received by the City Recorder on November 22, 2010, copies of which are attached hereto and incorporated by reference.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:
