RESOLUTION NO. 2336

A RESOLUTION OF THE CITY OF WILSONVILLE AUTHORIZING THE CITY ENGINEER TO SIGN A PROFESSIONAL SERVICES AGREEMENT WITH MACKAY & SPOSITO, INC. TO PROVIDE PROFESSIONAL (ENGINEERING) SERVICES FOR THE 95TH & BOONES FERRY ROAD INTERSECTION IMPROVEMENTS.

WHEREAS, on June 06, 2011, the Wilsonville City Council adopted a Capital Improvement Program for the City that includes a FY 2011/12 appropriation of \$1,596,000 to fund the design and construction of the 95th and Boones Ferry Road Intersection Improvements, (Project No. 540.950.45030.00000.4041); and

WHEREAS, the Council approved Resolution No. 2092 authorizing \$474,269 for the preliminary and final design with MacKay & Sposito, Inc., which work has been completed; and

WHEREAS, MacKay & Sposito, Inc has coordinated with ODOT during the design of the improvements for work being done within the ODOT right-of-way; and

WHEREAS, the City Engineer seeks the services of an engineering firm to provide continuing professional services for the referenced project; and

WHEREAS, on the 22nd day of February, 2005, the City of Wilsonville adopted Ordinance No. 578 adopting State findings, policies and methods of fostering competition and definitions consistent therewith, to provide for competitive bids or proposals, providing for contracting officers and the creation of procedures for the screening and selection of professional services; and

WHEREAS, MacKay & Sposito, Inc., having been previously screened and duly selected for professional services on this project, has proposed to supplement City staff and accomplish the professional engineering services for a time and materials fee, not to exceed \$125,214.00 as follow on work; and

WHEREAS, Section 2.310 of the Wilsonville Code states that "The Wilsonville City Council is designated as a Local Contract Review Board under the State of Oregon Public Contracting Code"; and

WHEREAS, staff has determined that MacKay & Sposito, Inc. continues to be qualified to do the proposed work and that the fees, as proposed by MacKay & Sposito, Inc., are fair and reasonable based on other recently completed projects; and

WHEREAS, in the public interest the City Council acting as the Local Contract Review Board may exercise its rights to reject any proposals and waive informalities, if any; and

WHEREAS, the City of Wilsonville desires to execute a Professional Services Contract Agreement in a timely manner.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1. The recitals of findings above are incorporated by reference herein.
- 2. The City Council, acting as the Local Contract Review Board, does hereby exempt the award of a contract for engineering professional services from competitive bidding based on the qualification based selection process, is follow on work, and further concludes this award will not diminish competition and will result in substantial cost savings as other professional firms would have to charge for review of the previous engineering design work which is already known to MacKay & Sposito, Inc.
- 3. The City Council, acting as the Local Contract Review Board, does hereby approve and authorize the City Engineer to sign a Professional Services Agreement between the City of Wilsonville and MacKay & Sposito, Inc., a copy of which is marked Exhibit "A", attached hereto and incorporated herein, to provide the engineering professional services recited within for the referenced project.
- 4. Subject to final completion of all improvements specified in the contract documents and any supplemental changes, the City Engineer is authorized to certify the required improvements complete and make final payment including release of retainage.
- 5. The City Engineer is authorized to approve change orders to this contract so long as total project costs do not exceed the budget amount.
- 6. The City Council hereby authorizes the expenditures for this contract, not to exceed \$125,214.00, from the Fiscal Year 2011/12 budget as follows:

ISSUE STATEMENT

City Council has previously approved funding for the design of improvements to the intersection of 95th Avenue and Boones Ferry Road by MacKay & Sposito, Inc (M/S) to improve the level-of-service (LOS). Staff recommends extending a Professional Services Agreement to M/S to perform as needed technical and surveying services during construction of the project, since much of the work is within ODOT right-of-way. See attached exhibit "A".

BACKGROUND

The city has previously obtained the services of M/S to complete the design of the intersection improvements. All right-of-way and permits have been obtained. M/S has coordinated with ODOT staff in developing the current improvement plans as well as performing the topographic surveying required. Staff held an open house with surrounding property owners on December 6th, 2011. Staff is currently advertising for bids from pre-qualified contractors in the Daily Journal of Commerce.

RELATED POLICIES/BUDGET CONSIDERATIONS

Council has approved funding for this construction project to move forward in the 2010/11 budget.

PROPOSED IMPROVEMENTS


The following is a list of improvements for the intersection of 95th Avenue and Boones Ferry Road. These improvements will correct the existing intersection configuration and improve safety, capacity and intersection level of service to reestablish the cities minimum level of service (LOS D). Due to the volume of traffic both now and over the 20 year design life and existing safety issues at this intersection, ODOT has required some reconfigurations for both traffic and pedestrians, since this intersection lies within ODOT's jurisdiction:

- A second left turn lane will be added to Boones Ferry Road for traffic travelling to 95th Avenue southbound to Commerce Circle westbound. (Capacity)
- A second receiving lane will be added on 95th Avenue to receive traffic from the additional left turn lane listed above. (Capacity)
- A second right turn lane will be added to 95th Avenue for traffic traveling to Boones Ferry Road southbound to the Elligsen interchange. (Capacity)

- The southwest signal pole will be placed in a location to accommodate a future southbound lane widening on the west side of Boones Ferry Road to accommodate the Coffee Creek Industrial Area.
- > Commerce Circle north left turn on to 95th Avenue will be eliminated and the intersection will be converted into a right in/right out movement only. Additionally, a small concrete median will be added to prevent vehicles from making the left turn. Commerce Circle traffic will access 95th Avenue northbound from the existing Commerce Circle south signal. (Safety)
- The existing 95th Avenue left turn median will be converted into a combination left turn and southbound lane. This lane will change to a left turn only at the Commerce Circle south signal. This will maintain access to the properties on the east side of 95th Avenue while providing enough distance for southbound 95th Avenue traffic to merge prior to the left turn lane at the Commerce Circle south signal. (Capacity/Access)
- The pedestrian crossing on the south leg of the 95th Avenue and Boones Ferry Road intersection will be removed as a condition from ODOT for pedestrian safety due to the dual left and dual right movements as part of signal operation. It should be noted that there is no pedestrian access on the north side of Boones Ferry Road east of the commercial driveway to the Commerce Center South development. (Safety)
- > Street lighting will be added on 95th Avenue from Commerce Circle south signal north to Boones Ferry Road completing the street lighting infill for 95th Avenue. (Safety)
- > Sidewalks and bike lanes are being retained and relocated based on the newly created horizontal designs. (Capacity/Safety)
