SUBJECT: Acceptance of Bids for the Seely Ditch Fence Project

On August 11, 1982, at 2:00 pm in City Hall sealed bids were opened by staff for the Seely Ditch Fence Project. The Project was bid to include two options 1) Headwall Fencing 2) Retention Fencing for the Bridge Structure. Guardrailing will be put up seperately from this contract by staff.

The bidding went as follows:

The City Council approved Resolution No. 260 on July 19, 1982, which approved Change Order #4 for the Seely Ditch Project. Change Order No. 4 reduced the project by \$11,169.00 by excluding the fence installation from the project, in order to have a seperate sealed bid on the fence.

Low bidder for the Seely Ditch Fence Project including the Headwall Fence and the Retention Fence is Town and Country Fencing Co. of Oregon for a total cost of \$8,830.00. The initial cost for fence under Change Order #4 was to be \$11,169.00 of which the headwall fencing and retention fencing were not included. Memo to Mayor and City Council

Initial cost saving by the City bidding the Seely Fence seperately is \$2,339.00 with the addition of the headwall fencing and retention fencing. The original projection by staff of the cost saving was between \$3,000.00 and \$5,000.00.

Recommendation

- 1. Accept the bid from Town and Country Fencing Co. of Oregon of \$7,989.00 for the Seely Ditch Fence, \$597.00 for the Headwall Fence, and \$244.00 for the Retention Fence for a total contract price of \$8,830.00.
- 2. Approve for the Mayor to sign the Seely Ditch Fence Contract Documents to include the Headwall Fence and Retention Fence.
- 3. After the completion of #2 above staff to issue a notice of award of contract, and a notice to proceed with the construction of the Seely Ditch Fence as bid.
