

RESOLUTION NO. 346

A RESOLUTION DECLARING A NUISANCE DESCRIBED IN THE WILSONVILLE CODE, SECTION 6.200(1)(e) ON THE PROPERTIES AS DESCRIBED HEREIN.

WHEREAS, the Wilsonville Code, Section 6.200(1)(e) provides that where the maintenance of grass, weeds and noxious vegetation is maintained in such a manner as to be declared a nuisance affecting the public safety; and

WHEREAS, the nuisance may be abated in the manner prescribed in Sections 6.220 to 6.230.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Wilsonville City Council as follows:

A. A nuisance as prescribed in Section 6.200(1)(e) of the Wilsonville Code and more specifically described as a hazardous condition that may cause fire exists on the properties as listed one (1) through thirty-six (36) and described below are to be abated under the provisions of Section 6.210 of the Wilsonville Code.

The Building Official shall take action as prescribed in Section 6.220 through 6.230 of the Wilsonville Code to abate the nuisance existing on the aforementioned properties and cause to be posted a notice upon the properties to be abated of such nuisance as prescribed in Section 6.222 of the Wilsonville Code.

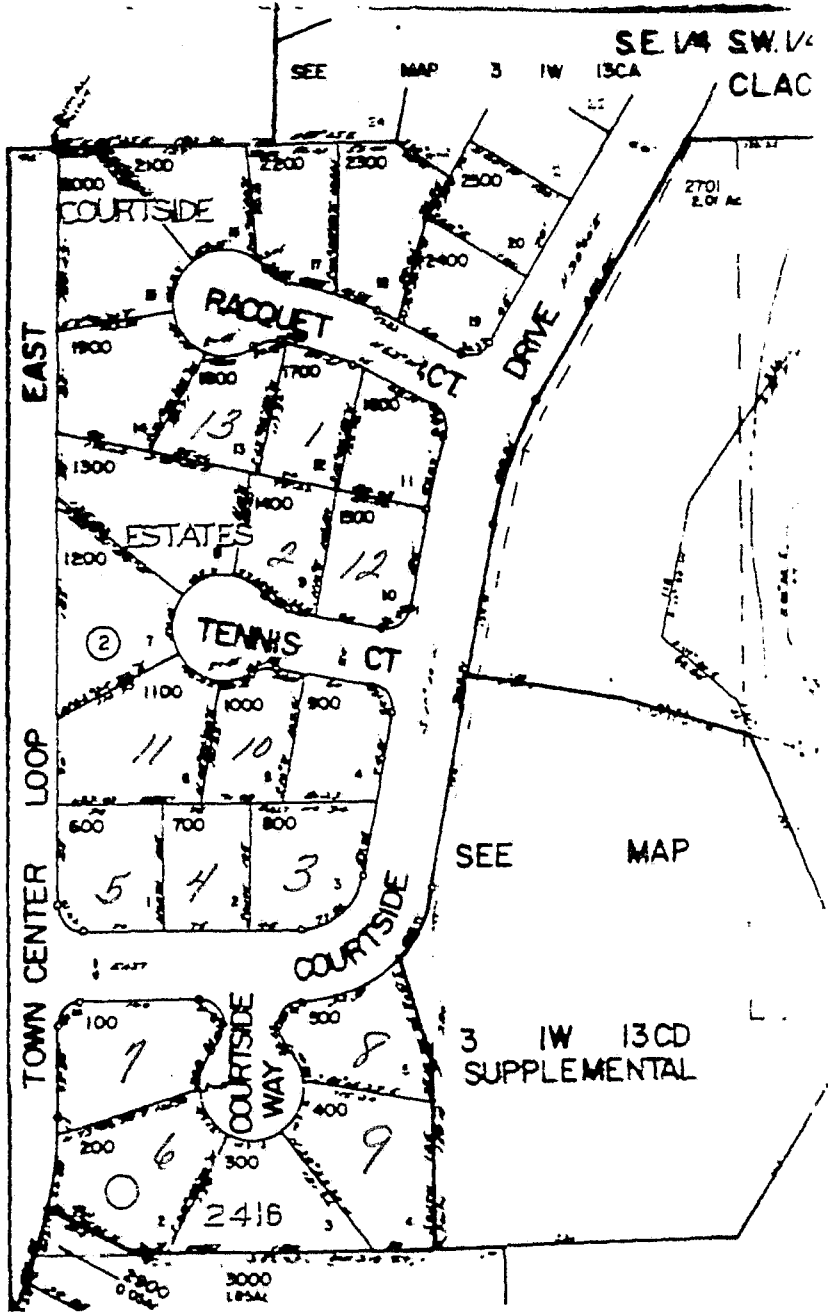

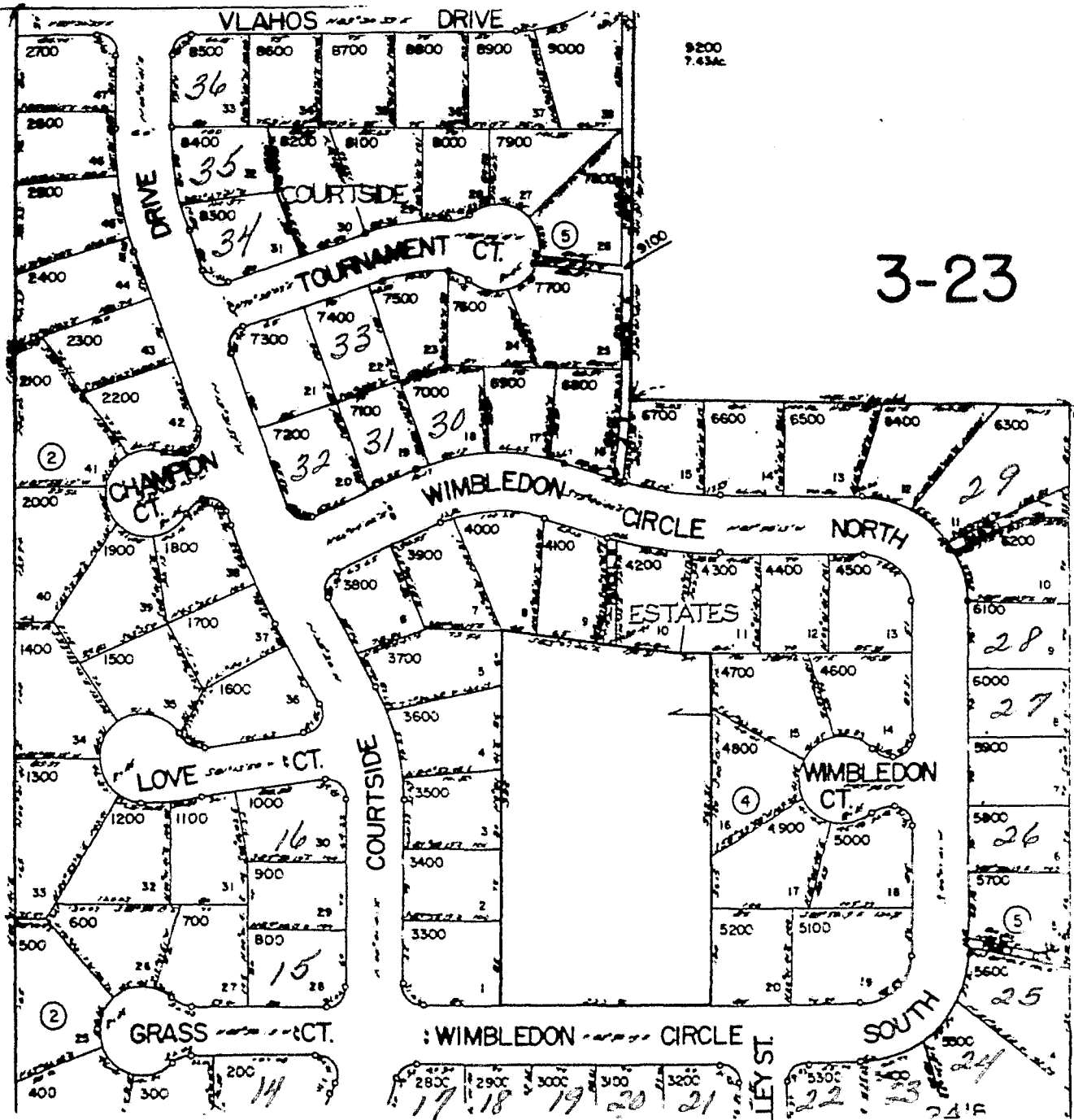
