
WHEREAS, the city staff has prepared a report on the above captioned subject which is attached hereto as Exhibit "A"; and

SUBJECT: FENCING CHARBONNEAU RESERVOIR - WIEDEMAN PUMP  
STATION

With the adoption of the 1983-84 budget, the City Council approved the sum of \$9564 from Account Number 03-55 Water Fund, 71312 for the installation of a chain link fence around the Wiedeman Pump Station and Charbonneau Reservoir. The ever increasing population of persons in and around this area has made it necessary to control access to this property. On numerous occasions throughout the past three years, these sites have been vandalized in one fashion or another.

From staff's preliminary estimates from quotes by fencing contractors, the cost for these fence installations would be between \$6000 and \$7000. Attached, you will find a copy of a fencing specification utilized for the Seely Ditch fence. Staff will prepare the plans and specifications in much the same manner as the Seely Ditch Fence Project with the exception of particulars pertaining to each site referred to herein.

RECOMMENDATION

1. Authorize staff to prepare plans and specifications for construction of chain link fences for the Wiedeman Pump Station and Charbonneau Reservoir.
2. Authorize staff, upon completion and approval by the Public Works Department of the plans and specifications, to advertise to receive sealed bids for this project.
3. Finance Director has indicated that funds are available for said project from Account No. 03-55-71312.
