

RESOLUTION NO. 408

A RESOLUTION APPROVING THE BIDS; ACCEPTING THE QUALIFIED LOW BID SUBMITTAL; AND AWARDING THE CONTRACT TO ASSOCIATED LANDSCAPE AND SUPPLY FOR LOCAL IMPROVEMENT DISTRICT NO. 6 LANDSCAPING IMPROVEMENTS.

WHEREAS, the City Council did approve Resolution No. 376, "A RESOLUTION AUTHORIZING STAFF TO APPROVE FINAL PLANS AND SPECIFICATIONS; APPROVING ROBERT PERRON TO PREPARE FINAL PLANS AND SPECIFICATIONS; AND AUTHORIZING STAFF TO ADVERTISE TO RECEIVE SEALED BIDS FOR LOCAL IMPROVEMENT DISTRICT NO. 6 - LANDSCAPE IMPROVEMENTS", at their regularly scheduled Council meeting held February 6, 1984 in the Council Chambers, 30000 S. W. Town Center Loop East at 7:30 o'clock p.m.; and

WHEREAS, staff did review the plans and specifications as designated by Resolution No. 376, and hereby acknowledges approval of the plans and specifications according to the standards set forth in the City of Wilsonville Public Works Standards and all requirements as set forth by the Wilsonville Design Review Board; and

WHEREAS, advertisements were published in the Wilsonville Times on June 14th and 19th, 1984 and the Daily Journal of Commerce on June 8th, 11th and 12th, 1984 as is required for public bidding

under Oregon Revised Statute (ORS) 279.025 "Requirement for Advertisements for Bids"; and

WHEREAS, all bids were received prior to 2:00 o'clock p.m. July 9, 1984, and were publicly opened after 2:00 o'clock p.m. in the Council Chambers of City Hall, 30000 S. W. Town Center Loop East. Five (5) qualified bidders submitted bid proposals according to the plans and specifications as completed by Robert Perron Landscape Architects and as approved by the City of Wilsonville Public Works Department. The bidders and bids are listed in Exhibit "A" attached hereto for your reference; and

WHEREAS, the qualified low bid was submitted by Associated Landscape and Supply for a total bid of one hundred, twenty-one thousand, two hundred, ten dollars and no cents (\$121,210.00) for the Local Improvement District No. 6 - Landscape Improvements; and


WHEREAS, funds shall be allocated from Account No. 10-69-74403 for those costs attributed to the construction of the landscape improvements as bid by Associated Landscape and Supply.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the City Council of the City of Wilsonville that:

1. Acknowledgement that all bids were received, publicly opened and approved as being completed for consideration for award according to the provisions of Oregon Revised Statute 279.025.


2. Accepting the contract of the low qualified bidder and awarding the contract to the low qualified bidder, Associated Landscape and Supply for a total bid price of one hundred, twenty-one thousand, two hundred, ten dollars and no cents (\$121,210.00) for the Local Improvement District No. 6 - Landscape Improvements.
3. Authorize the expenditure of funds from Account No. 10-69-74403 for payment of costs attributed to the bid from Associated Landscape and Supply.
