
WHEREAS, the city staff has prepared a report on the above captioned subject which is attached hereto as Exhibit "A"; and

WHEREAS, interested parties, if any, have had an opportunity to be heard on the subject.



SUBJECT: LAND AND WATER CONSERVATION FUND
GRANT APPLICATIONS

The Parks and Recreation Commission requests Council authorization to proceed with a grant application to the State Parks and Recreation Division for a 1989 Federal Land and Water Conservation Fund grant.

The grant would be for the acquisition of a five acre piece of property, located east of Montebello Subdivision, east of Montebello Street and south of an unimproved section of Evergreen Avenue.

The grant, if awarded, will be a fifty-fifty matching grant. The approximate cost of the acquisition will be \$70,000, or fair market value, whichever is less. The City's portion would be approximately \$35,000. This amount would be budgeted for in the 1988-89 Parks and Recreation Department's Reserve Fund (Park Development Fees).

The Parks and Recreation Commission requests Council direction for the Parks and Recreation Director to proceed with the grant process and Council authorization of the project to the State Parks and Recreation Division.

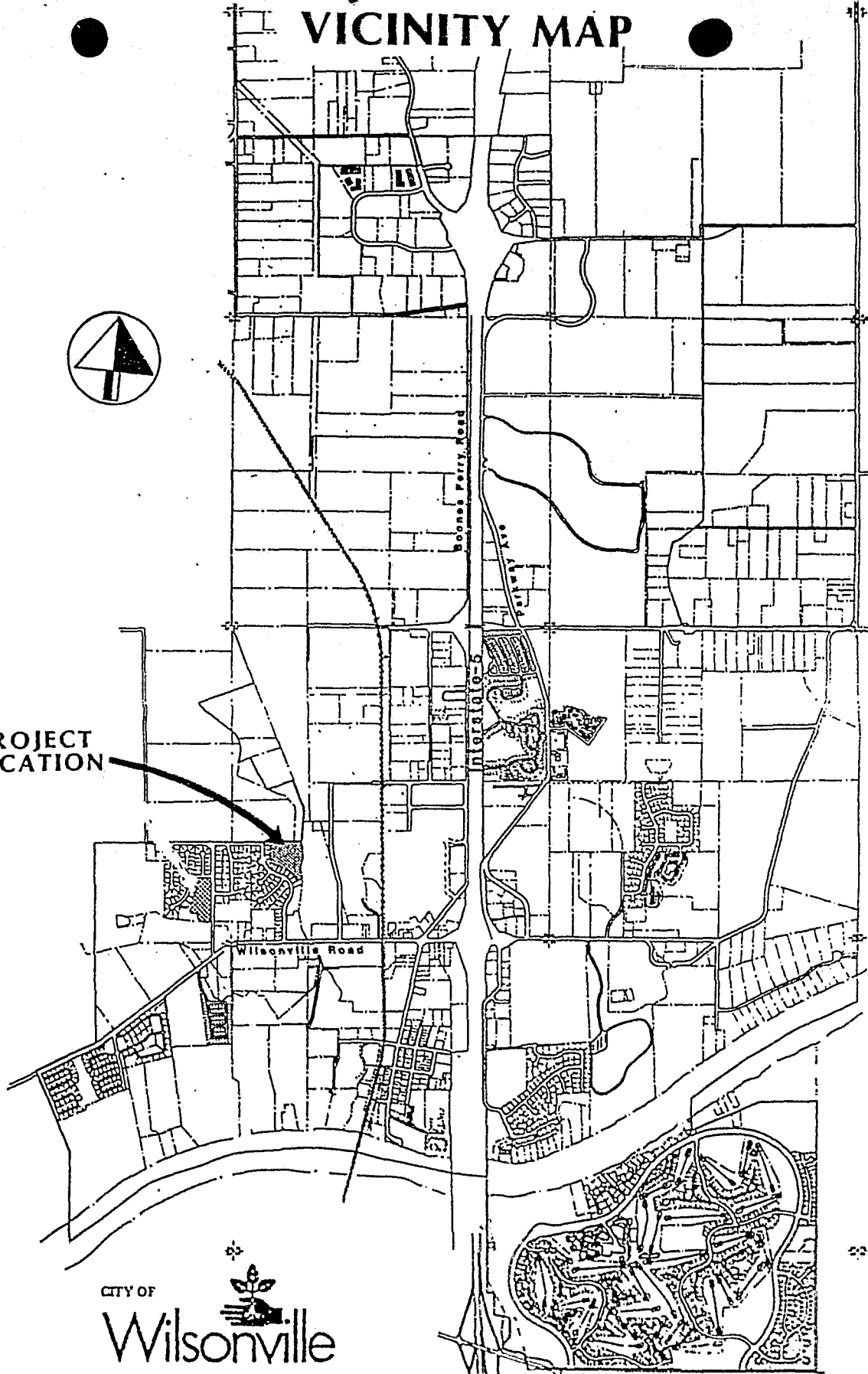

VICINITY MAP

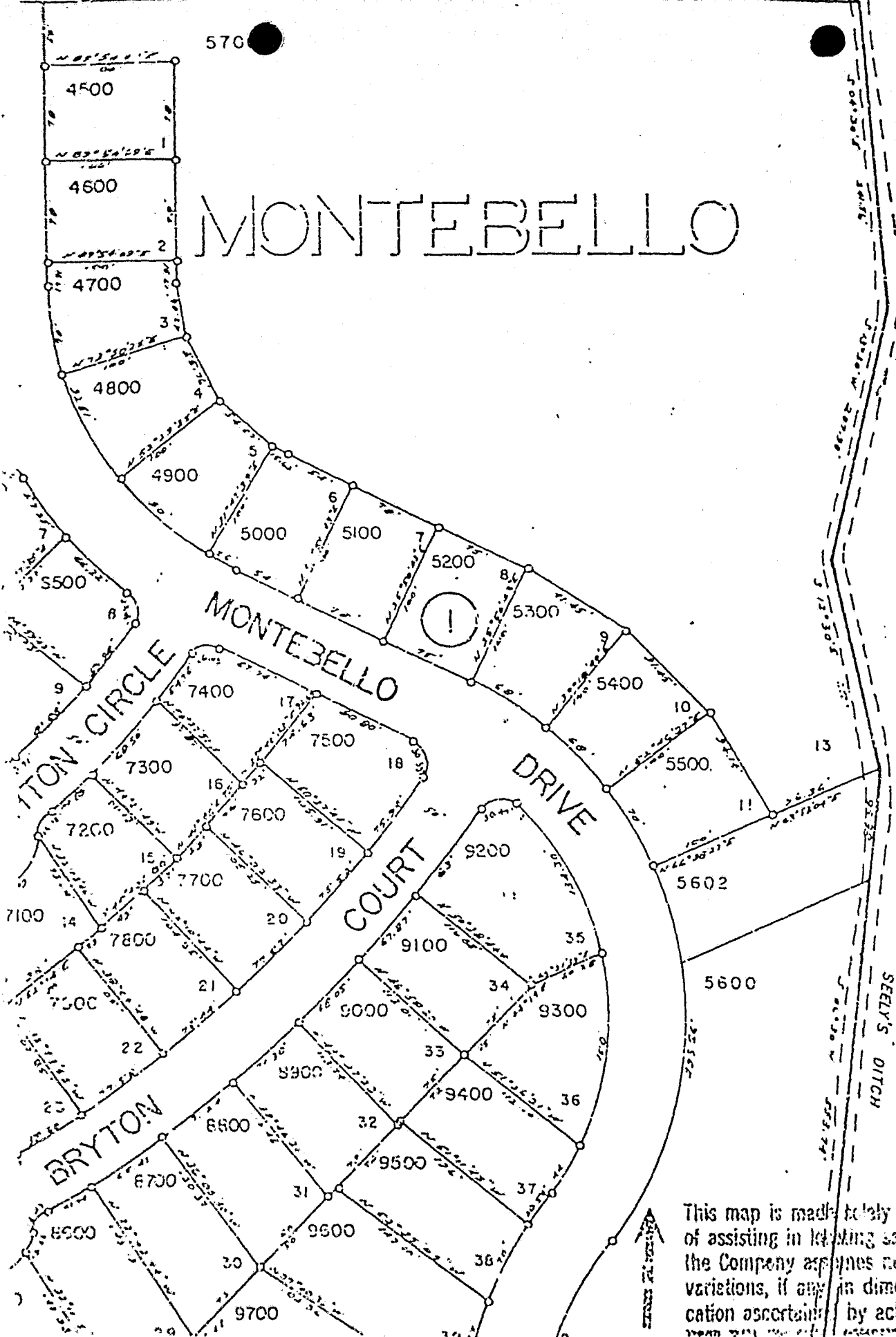


PROJECT
