WHEREAS, interested parties, if any, have had an opportunity to be heard on the subject.



 RE: RECOMMENDATION FOR LIBRARY FURNISHINGS

On Monday, March 14, 1988 at 1:00 p.m. the formal bids were opened regarding the furnishings for the new library structure. The Invitation to Bid was written and published in accordance with the City's approved purchasing rules. A Bid document manual outlining all the furniture specifications, as well as all conditions and requirements associated with this purchase was prepared and distributed to all 16 interested vendors. (A copy of the manual is provided in your Council packet).

For bidding purposes, the actual bid was separated into four lots Lot #1 - Wood Shelving/Bookcases, Lot #2 - Work Tables, Lot #3 - Mini-Conference Room and Lot #4 - Tables, Chairs and Misc. Furnishings. Bidders could bid on any or all lots. We had hoped that by breaking the bid into the various lots that local cabinet makers and vendors would possibly bid on this project. This division also allowed us to eliminate a "Lot" if the bids had come in "over" the estimated budgeted amounts.

Three formal bids were received and the following table shows the "total package" bid for each. A detailed tabulation is attached along with a complete listing of all vendors who requested the bid manual.

RECOMMENDATION:

All the bids were received in complete form, including the required bid bond and signed proposal. After reviewing the bid documents, I recommend that it be in the City's best interest to award the bid by the "Total Package" price without the alternate of flakeboard end-panels and table top interiors, to the low bidder Timmerman Company of Bothell Washington.
