

RESOLUTION NO. 803

A RESOLUTION GIVING PRELIMINARY APPROVAL TO PHASE I OF THE 1990 WILSONVILLE TRANSPORTATION PLAN (CARL BUTTKE, INC.) AND INITIATING AN AMENDMENT TO THE COMPREHENSIVE PLAN AND MAP.

WHEREAS, in March, 1990, the City Council directed the Wilsonville Transportation Advisory Commission to begin development of a proposed two-phase Transportation Master Plan; and

WHEREAS, the Council accepted the Transportation Advisory Commission's recommendation to select the traffic engineering firm of Carl Buttke, Inc. to prepare the Plan; and

WHEREAS, the Transportation Advisory Commission has completed the process of inventorying public facilities; forecasting traffic; developing, evaluating and choosing alternatives; holding public meetings that were identified in the Phase I planning schedule; and developing phase I of the Transportation Master Plan; and


WHEREAS, on December 3, 1990, the City Council initially reviewed the draft of the Phase I Transportation Plan that was prepared and presented by Carl Buttke, Inc. and the Transportation Advisory Commission, and is now on file with the City Recorder.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. City Council hereby gives its conceptual and preliminary approval to phase I of the 1990 Wilsonville Transportation Plan, a copy of which is marked Exhibit "A", has been previously presented to the City Council and placed on file with the City Recorder, and by this reference is incorporated herein.


2. The Council directs city staff to prepare and initiate all necessary and appropriate land-use applications to the Planning Commission including, but not limited to, amendment of the Wilsonville Comprehensive Plan Text and Maps.

ADOPTED by the City Council of the City of Wilsonville at a regular meeting thereof this 17th day of December, 1990, and filed with the Wilsonville City Recorder this same date.
