

**RESOLUTION NO. 1158**

**A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE NOVEMBER 8, 1994 GENERAL ELECTION.**

WHEREAS, at the General Election held November 8, 1994, the electorate of the City of Wilsonville cast ballots for the position of two City Council positions, each to be a four term; and

WHEREAS, the election of the registered voters of Clackamas County was conducted at the polls; and

WHEREAS, the County Clerk of Clackamas County, who by statute, is in charge of conducting all elections, has filed an abstract of the tally of votes cast at the election, which tally was received on December 1, 1994.


2. Based upon the adopted canvass of votes, the City Council affirms that Jane Leo and Tim Leahy have each been elected to the position of City Councilor for a four term.
