

**RESOLUTION NO. 1223**

**A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE  
SEPTEMBER 19, 1995, SPECIAL ELECTION.**

WHEREAS, at the Special Election held September 19, 1995, the electorate of the City of Wilsonville cast ballots for Bond Measure 3-50, Library Expansion; and Bond Measure 3-51, Memorial Park Improvement; and

WHEREAS, the election of the registered voters of Clackamas County was conducted by mail; and

WHEREAS, the County Clerk of Clackamas County, who by statute, is in charge of conducting all elections, has filed an abstract of the tally of votes cast at the election, which tally was received on September 22, 1995.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:


