RESOLUTION NO. 1410

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WILSONVILLE, OREGON, AUTHORIZING THE MAYOR TO SIGN AN INTERGOVERNMENTAL AGREEMENT CONCERNING THE FINANCIAL TERMS OF SHARING REVENUES FROM THE CLACKAMAS COUNTY GAS TAX AND VEHICLE REGISTRATION FEE ORDINANCES IF APPROVED BY VOTERS.

WHEREAS, ORS Chapter 190 authorizes cities and counties to enter into intergovernmental agreements for the performance of any function that one party to the agreement has authority to perform; and

WHEREAS, ORS 203.035 describes the power of county governing bodies or electors over matters of county concern, and specifies that they have the power to create ordinances to exercise their authority over matters of county concern. ORS 221.410 and City Charters describe the power of cities to govern and control their local affairs. Under these authorities, both counties and cities have the power to create ordinances in matters which concern them, and to submit ordinances to the voters under their jurisdiction; and

WHEREAS, Clackamas County intends to create two ordinances to submit to voters throughout the county. One ordinance will propose a gasoline tax, and may include diesel fuel in the definition of gasoline. The other ordinance will propose a vehicle registration fee. These ordinances, if passed, will apply both inside and outside incorporated areas; and

WHEREAS, the taxes and fees provided for by these ordinances are intended to be used for the construction, reconstruction, improvement, repair, maintenance, operation and use of public highways, roads and streets, to benefit the public generally, including specifically residents of the cities, and the county. Both the cities and the county agree that the county will pursue the enactment of these ordinances, and the revenues shall be apportioned between the county and the cities by using the distribution formula set out in an intergovernmental agreement; and

WHEREAS, for the reasons and pursuant to the authority stated above, the Clackamas County Board of Commissioners and the City Council of Wilsonville deem it in the best interests of the county and the cities of the county to seek voter approval of the aforementioned Gasoline Tax Ordinance and Vehicle Registration Fee Ordinance. NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. That the Mayor be authorized to sign an intergovernmental agreement agreeing to the financial terms for distribution of the revenues.
