Program Descriptions

1. 5307 Urbanized Area Formula

Project name: Preventive Maintenance and Scheduling Software

Description: For preventive maintenance and transit scheduling software.

2. 5307 Urbanized Area Formula and 5339 Bus and Bus Facilities Formula

Project name: Service Expansion Buses and Preventive Maintenance

Description: For three Compressed Natural Gas (CNG) cutaway buses and related amenities to serve on the Clackamas Town Center route and for preventive maintenance. (This project was included in FY2024 and the vehicles are expected after the fiscal year ends, so it is included in the POP for a second year.)

3. STBG to 5307 (Metro pass-through)

Project name: SMART Commute Options and Safe Routes to School Programs

Description: These funds support staff time for the Transportation Demand Management (TDM) Programs supporting commute and safe routes to school programs, and focuses on promoting and facilitating transportation options other than driving alone such as walking and biking for business and the residential community. Funding partially supports one Program Coordinator, one Grants and Programs Manager, one Mobility Technician and two summer Transportation Options Interns.

4. 5310 Formula Enhanced Mobility of Seniors and Individuals with Disabilities

Project Name: Travel Training

Description: Contract with third party vendor for mobility management and special transportation service provider in the greater Portland region to provide free travel training for seniors and people with disabilities using transit service in and around Wilsonville.
